### Westfield Tannery Site a Keystone Opportunity Zone

The Westfield Business formerly Westfield Tannery, has been designated a Keystone Opportunity Zone by the Pennsylvania Department of Community and Economic Development (DCED). This designation provides tax exemption for 10 years. The ultimate goal is to complete the necessary environmental clean-up and redevelop the 17.5-acre site to bring jobs back to Westfield.

NTRPDC and TCDC part-Park (Westfield, Tioga County), nered with the taxing bodies for Westfield: Northern Tioga School District, Tioga County, Westfield Borough, and Westfield Township. These partners saw the significant opportunities the redevelopment of this site offers for the Westfield area and agreed to make the site tax exempt to encourage redevelopment. After the three taxing bodies agreed to this initiative, NTRPDC worked with TCDC to 1529.

apply to DCED for the status.

The former Westfield Tannery closed its doors in 2005; approximately 200 jobs were lost. Since that time, the site has not been useable. TCDC has taken ownership of the site to oversee its cleanup and encourage reinvestment by the private sector.

# NE Regional Healthcare Industry Partnership

Partnership funding continues to support training of health care workers.

Since the start of our program year on October 1, 2013, several trainings subsidized with Healthcare Worker Training grant funds have been held in the region.

In November, six staff from Memorial Hospital and Darway Eldercare completed the CNA certification program at Memorial Hospital in Towanda. Upon successful completion of the program the participants received wage increases and certification as Nurse Aides.

Also in November, 12 nurses from Geisinger Healthcare and Hazleton General Hospital participated in a twoday CNOR review in the operating nursing specialty. After passing the exam, nurses received a wage increase or bonus, depending on employer policy.

The Northeast Regional Healthcare Industry Partnership represents the Workforce Investment areas of the Northern Tier, Lackawanna, Luzerne/Schuylkill, and the

Poconos. Sixty-four health care employers actively participate in the partnership, including every major health care facility in the Northern Tier. To date, worker training grant funding has been used to help upgrade the skills of more than 3,000 employees in the region. Additionally, thousands of high school students have been educated about health careers through activities funded through the Healthcare Industry Partnership.

# Local Students Explore Health Careers

More than 130 students attend Tioga County Health Career Fair.

Most high school students have seen a doctor or nurse at work, but it wasn't until the Tioga County Health Career Fair that many learned of other exciting health care careers, such as speech therapy, respiratory therapy, occupational therapy, and radiology.

These and more than three dozen other careers were highlighted at the event held at Pennsylvania College of Technology's North Campus in November. More than 130 high school students attended the fair.

Before participants circulated among the tables of health care professionals, Ferlin Patrick, HR representative from Laurel Health System, spoke to the students about employer expectations. Nathan Smyth, Associate Dean of Health Sciences at Penn College, talked about which high school classes would prepare students for training in a health career.

"This was an incredibly successful event, with great support from local employers and other community partners," says Sherry Felten, NTRPDC Workforce Program Manager. "Health care professionals play such an important role in our society, and it's important that our young people learn about these careers that offer rewarding benefits such as competitive pay and opportunity for advancement."

The annual event was

# Unemployment Compensation Seminar Held

#### Hosted by PA Careerlink and NE Regional Healthcare Industry Partnership.

PA CareerLink® and the Northeast Regional Healthcare **Industry Partnership recently** hosted an Unemployment Compensation seminar sponsored by NTRPDC.

Two sessions were presented by Nancy Smithbauer of the PA Department of Labor and Industry, Unemployment Compensation Service Center. She covered two unemployment compensation topics: "What's New in

UC" and "Quits & Discharges." Employers were provided with an overview of the latest UC law changes and the process the UC service center follows when investigating and issuing determinations relating to guits and discharges. Attendees also had an opportunity to ask questions pertaining to their particular situations.

Sessions were held in Wysox and Tunkhannock and

drew nearly 90 employer representatives. "These sessions are very valuable to our local employers. Unemployment compensation is a complex topic for employers and we plan to bring additional sessions to the area," says Melissa Fleming, PA CareerLink Site Administrator.

NTRPDC provides these services at no cost to Northern capabilities of CCR/FedReg, Tier businesses. It is not necessary to pay a private company for this service (some charge \$599 or more).

Business owners can also update their registration on their own. Visit the SAM website at www.sam.gov to view their demonstration videos

and review the FAOs.

The System for Award Management (SAM) is the official U.S. Government system that consolidated the ORCA, and EPLS. There is NO fee to register for this site.

## Bringing Business to Pennsylvania

#### Pennsylvania Awarded 'Make It in America' Funding.

A Pennsylvania economic and workforce development initiative was one of only 10 projects nationwide selected for funding as part of the federal government's Make It in America Challenge.

The main goal of this initiative is to bring business and jobs back to the United States. NTRPDC and partnering organizations will work together to familiarize themselves with foreign markets as well as the state's industry clusters and ineeds to determine necessary workforce training, how to better market initiative, the Northern Tier Pennsylvania, and how to

best communicate with target employers. "Our focus is on increasing communication with potential international investors and more effectively showcasing the Northern Tier region's strengths, thereby increasing foreign direct investment and job creation throughout the region," says Kim Barnes, NTRPDC Deputy Director. This could include participating in foreign trade shows to build relationships with companies and trips to meet with foreign investors.

In conjunction with this Workforce Investment Board

will be working with other partners to develop training opportunities for high-skilled incumbent and new employees. This skills training will focus mainly in the manufacturing sector and will include science, technology, engineering, and math skills. These educational and skills upgrades will involve employees in occupations such as engineering and mechatronics.
