# I. Items for Discussion

## A. Approve August 10, 2015 Minutes

- A motion was made by Jim Weaver to approve the 8/10/15 Meeting Minutes, seconded by Bob Getz, the motion carried unanimously.

### B. 2013 - 2016 Administrative Actions and Amendments -

District 3.0 – Amendments & Admin Actions

- Project #8 This project was increased to meet new estimates
- Project #16 This project was increased to meet new estimates
- Project #18 This project was increased to meet new estimates

District 4.0 - Amendments & Admin Actions

- Project #1 This project has had its PE phase advanced
- Project #4 This project had its low bid increased

### Amendments:

- Project #2 This project's funds have been advanced
- Project #3 This project is now 100% state
- Project #4, #7-10 These projects were increased to meet new estimates
- These actions required an amendment, a motion was made by Carey Mullins, seconded by Alan Hall and carried unanimously

### **C. STC Commissioner presentation**

- STC Commissioner Frank Paczewski gave a presentation on the state's 12 year plan, specifically the public participation portion. The STC had created an online survey for public participation this year. Every county in the state was represented by some form of public input. Most concerns dealt with safety, pavement conditions, biking/walking, and bridge conditions. In our region road conditions was the #1 priority followed by bridge conditions and safety.

#### D. Wellsboro/Johnston Airport Discussion

– Craig Musser, Wellsboro/Johnston Airport Manager, discussed some issues the airport is dealing with from SR 3029. SR 3029 is affecting the airports approach of planes into the airport with the only way to alleviate the issue being to close the road. The airport would also like to eventually expand to the east where the road currently is, the airport would like to request a study of closing SR 3029. Although the "official" detour would only be 1 or 2 miles. The township stated that most people would use the township road off or SR 3029 and the road can't handle the increased traffic. Carey Mullins asked Brian Baker to set up a conference call with all parties involved to be held in early January 2016 to discuss this further.

### E. PennDOT District Bridge Presentation/Discussion

- Lloyd Ayers discussed PennDOT's process for local bridges. PennDOT can now manage projects from start to finish if the local entity agrees. This includes in house design if possible, surveying of the bridge, etc. which can promote cost savings. PennDOT will also do most engineering agreements on behalf of the municipality. This process can help with bridges that are a like that have similar maintenance issues be repaired and grouped together. Also, Lloyd mentioned PennDOT can now cast concrete beams for local municipalities. Lyold also mentioned District 3 and 4 will be meeting to discuss working together on some projects in District 4-0.

- Matt Williams has been working on the following projects:
  - The Upper Tioga River Authority Waterline Extension The county has loaned the group \$1 million towards the \$7.5 million needed to fund the project
  - The Marsh Creek Greenway has converted into a River Authority
  - Matt has also been working with municipalities that are looking for TAP money for streetscapes, but the program closes January 8<sup>th</sup>. Municipalities interested in TAP funding include Clifford Township, Lanesboro, and Nicholson Borough.
  - Matt also mentioned the DCNR C2P2 program is to open in Janury

Dist. 4.0 – Alan Hall voiced concerns to District 4.0 on some issues within Susquehanna County specifically on SR 171 at the Great Bend exit off I-81. The condition of the road off the interstate is very poor. Commissioner Hall mentioned he talked to George Roberts months ago but nothing has changed. Pictures of the issues were sent to 4.0.

Carey Mullins stated "All inquiries about the I-99 Designation are to be directed to District 3-0 Executive Sandra Tosca."
